Hubungan Pemahaman Kode Etik Keperawatan dengan Perilaku *Confidentiality* Perawat di Ruang Rawat Inap Rumah Sakit Tingkat III Baladhika Husada Jember

Abstrak

Kode etik keperawatan adalah Kode Etik Perawat Nasional Indonesia yang mewajibkan seorang perawat berpegang teguh terhadap kode etik sehingga kejadian pelanggaran etik dapat dihindari. Kesalahan melindungi informasi pasien merupakan privasi yang akan merugikan nama baik pasien dan keluarganya atau yang biasa disebut perilaku *confidentiality*. Pemahaman perawat tentang kode etik keperawatan yang baik akan mengurangi kemungkinan terjadinya malpraktik dan terjadinya kelalaian rendah. Penelitian ini menggunakan rancangan *corelation research* dengan desain penelitian *cross sectional* sedangkan teknik pengambilan sampel menggunakan total sampling. Subjek penelitian perawat yang berada di ruang rawat inap di Rumah Sakit Tingkat III Baladhika Husada Jember berjumlah 39 responden. Instrumen penelitian yang digunakan yaitu kuisioner pemahaman kode etik keperawatan dan perilaku *confidentiality*. Analisis data pada hasil *p value* $0,016 \leq 0,05$ artinya H1 di terima. Dengan demikian dapat disimpulkan bahwa ada hubungan pemahaman kode etik keperawatan dengan perilaku *confidentiality* perawat di ruang rawat inap Rumah Sakit Tingkat III Baladhika Husada Jember. Dengan demikian pemahaman kode etik keperawatan dapat mempengaruhi perilaku *confidentiality* perawat.

The Relationship between Nursing Code of Ethics Understanding and Confidentiality Behavior of Nurses in the inpatient room of the Baladhika Husada Level III Hospital Jember

Abstract

The nursing code of ethics is a code of ethics for Indonesian national nurses which obliges a nurse to adhere to a code of ethics so that ethical violations can be avoided. A mistake in protecting patient information is privacy that will harm the good name of the patient and his family or what is commonly known as confidentiality behavior. Nurses' understanding of a good nursing code of ethics will reduce the possibility of malpractice and low negligence. This study used correlation research design with cross-sectional research design while the sampling technique used total sampling. The research subjects of nurses who were in the inpatient room at the Level III Baladhika Husada Hospital Jember were 39 respondents. The research instrument used was a questionnaire on understanding the nursing code of ethics and confidentiality behavior. Data analysis on the results of p-value $0.016 \leq 0.05$ means that H1 is accepted. Thus it can be concluded that there is a relationship between understanding the code of ethics of nursing with the nurse's confidentiality behavior in the inpatient room of the Baladhika Husada Level III Hospital, Jember. Thus understanding the nursing code of ethics can affect nurses' confidentiality behavior.
