

## ABSTRAK

Pemerintah Desa Lengkong menyusun program yang bersumber dari Anggaran Pendapatan dan Belanja Desa (APBDes) Desa Lengkong, sebagai bentuk perlindungan sosial kepada kelompok Lansia. Penelitian ini bertujuan untuk menjelaskan bagaimana Pemerintah Desa Lengkong, dalam melakukan pemberdayaan dan perlindungan sosial terhadap kelompok rentan Lansia, melalui Implementasi kebijakan program bantuan lanjut usia Desa Lengkong. Penelitian ini menggunakan metode penelitian kualitatif dengan pendekatan deskriptif. Pengambilan data primer melalui kegiatan observasi dan wawancara, sedangkan data sekunder diambil melalui kegiatan studi literatur. Penelitian dilakukan selama 2 bulan (April dan Mei). Data-data kemudian diolah dengan reduksi data, penyajian data, dan penarikan kesimpulan. Hasil penelitian menjelaskan bahwa, program bantuan lanjut usia Pemerintah Desa Lengkong hanya menjadi agenda program pemberdayaan dan kesejahteraan masyarakat, yang diatur dan ditetapkan dalam APBDes Nomor 8 Tahun 2023, Tentang Anggaran Pendapatan Belanja Desa Tahun 2024. Dalam perkembangannya, PKH Lansia milik Kemensos menjadi program utama dalam bantuan Kelompok Lansia, sehingga bantuan Lansia yang berasal dari anggaran desa, cukup untuk menalangi Lansia yang tidak terdaftar sebagai kelompok penerima manfaat PKH.

## ABSTRACT

*The Lengkong Village Government developed a program sourced from the Lengkong Village Revenue and Expenditure Budget (APBDes), as a form of social protection for the elderly. This research aims to explain how the Lengkong Village Government, in carrying out empowerment and social protection of vulnerable groups of the elderly, through the implementation of the Lengkong Village elderly assistance program policy. This research uses qualitative research methods with a descriptive approach. Primary data were collected through observation and interviews, while secondary data were collected through literature studies. The research was conducted for 2 months (April and May). The data were then processed by data reduction, data presentation, and conclusion drawing. The results of the study explain that the elderly assistance program of the Lengkong Village Government is only an agenda of the community empowerment and welfare program, which is regulated and stipulated in APBDes Number 8 of 2023, concerning the 2024 Village Budget. In its development, PKH Elderly owned by the Ministry of Social Affairs became the main program in the assistance of the Elderly Group, so that Elderly assistance originating from the village budget was sufficient to cover the Elderly who were not registered as PKH beneficiary groups.*
