## Abstrak

Gangguan sensorik, sebagai kondisi patologis awal, dapat menyebabkan keterbatasan fungsional (seperti penurunan kemampuan aktivitas harian), yang pada gilirannya menyebabkan disabilitas, membatasi kemampuan individu untuk menjalankan peran sosial. Penelitian ini bertujuan untuk mendeskripsikan pengkajian dan diagnosis keperawatan syndrom geriatri pada lanjut usia dengan gangguan sensoris. Penelitian ini menggunakan design studi kasus menggunakan pendekatan proses keperawatan dengan pengkajian berbasis pada ICOPE. Partisipan dalam studi ini sebanyak tiga orang lanjut usia. Analisis menggunakan pendekatan kualitatif secara tematik. Hasil pengkajian menunjukkan ketiga klien mengalami penurunan fungsi intrinsik mencakup penurunan penglihatan, pendengaran, peraba dan perasa yang berdampak pada cedera dan penurunan kognisi dan perubahan status mental. Hasil diagnosis yang didapat dari lanjut usia dengan gangguan sensoris (*impairment of sensory*) terdapat satu domain masalah keperawatan yang teridentifikasi terdampak sehingga menimbulkan potensi utama munculnya diagnosis keperawatan. Domain tersebut yaitu domain keamanan dan proteksi yang mencakup risiko cedera (D. 0136). Gangguan sensorik pada lanjut usia bukan merupakan kondisi yang mengancam jiwa, namun, gangguan ini dapat menyebabkan keterbatasan psikologis, psikososial, dan fungsional dalam mobilitas, aktivitas kehidupan sehari-hari, dan aktivitas sosial

*Case Study Review: Nursing Assessment and Diagnosis of Geriatric Syndrome in Elderly with Sensory Disorders*

*Abstract*

*Sensory impairment, as an early pathological condition, can cause functional limitations (such as decreased ability of daily activities), which in turn causes disability, limiting the individual's ability to carry out social roles. This study aims to determine Describe the assessment and nursing diagnosis of geriatric syndrome in the elderly with sensory impairment. This study uses a case study design using a nursing process approach with an assessment based on ICOPE. Participants in this study were three elderly people. The analysis used a thematic qualitative approach. The results of the assessment showed that the three clients experienced a decrease in intrinsic function including decreased vision, hearing, touch and feeling which resulted in injury and decreased cognition and changes in mental status. The diagnostic results obtained for elderly individuals with sensory impairment identified one nursing problem domain as impacted, potentially leading to a major nursing diagnosis. This domain is the safety and protection domain, which encompasses the risk of injury (D.0136). Sensory disorders in the elderly are not life-threatening conditions, however, these disorders can cause psychological, psychosocial, and functional limitations in mobility, activities of daily living, and social activities.*
