

**HUBUNGAN ANTARA ORIENTASI MASA DEPAN
DALAM HUBUNGAN ROMANTIS DENGAN
KOMITMEN PERNIKAHAN
PADA PENGAJU DISPENSASI NIKAH
DI PENGADILAN AGAMA JEMBER**

INTISARI

Pernikahan dini melalui dispensasi nikah masih marak terjadi di Indonesia, termasuk di Kabupaten Jember. Fenomena ini menimbulkan permasalahan baru karena remaja yang menikah sering kali belum matang secara psikologis, sehingga berisiko rendah dalam membangun komitmen pernikahan. Penelitian ini bertujuan untuk mengetahui hubungan antara orientasi masa depan hubungan romantis dengan komitmen pernikahan pada remaja pengaju dispensasi nikah di Pengadilan Agama Jember. Penelitian menggunakan pendekatan kuantitatif korelasional dengan total sampel sebanyak 106 remaja yang dipilih melalui metode total sampling. Instrumen yang digunakan meliputi *Skala Future Time Orientation of Romantic Relationship* (FTORR) (8 aitem; $\alpha=0,677$) yang diadaptasi dari Öner (2000) dan Putri (2010), dan Skala Komitmen Pernikahan (15 aitem; $\alpha=0,937$) yang diadaptasi dari Zakiah (2012). Hasil penelitian menunjukkan adanya hubungan signifikan antara orientasi masa depan hubungan romantis dengan komitmen pernikahan ($r = 0,249$; $p < 0,05$). Semakin tinggi orientasi masa depan hubungan romantis pengaju dispensasi nikah maka semakin tinggi pula komitmen pernikahan.

**THE CORRELATION BETWEEN FUTURE TIME ORIENTATION
ROMANTIC RELATIONSHIP AND MARITAL COMMITMENT AMONG
MARRIAGE DISPENSATION APPLICANTS
AT THE JEMBER RELIGIOUS COURT**

ABSTRACT

Early marriage through marriage dispensation remains prevalent in Indonesia, including in Jember Regency. This phenomenon creates challenges, as adolescents who marry are often not yet psychologically mature, which may weaken their ability to build marital commitment. This study aims to examine the relationship between future time orientation of romantic relationships and marital commitment among adolescents applying for marriage dispensation at the Jember Religious Court. This research employed a quantitative correlational approach with a total sample of 106 adolescents selected using total sampling. The instruments used were the Future Time Orientation of Romantic Relationship (FTORR) scale adapted from Öner (2000) and Putri (2010) (8 aitem; $\alpha=0,677$), and the marital commitment scale (15 aitem; $\alpha=0,937$) adapted from Zakiah (2012). Analysis revealed a significant relationship between future orientation in romantic relationships and marital commitment ($r = 0.249$; $p < 0.05$), The higher the future time orientation of romantic relationships among marriage dispensation applicants, the higher their marital commitment.
