

ABSTRAK

Judul : **“Formulasi Rencana Pembangunan Jangka Menengah Desa Randuagung Menuju Desa Mandiri”**

Penelitian ini bertujuan untuk mendeskripsikan formulasi (proses penyusunan) Rencana Pembangunan Jangka Menengah Desa menuju Desa Mandiri, dilihat dari kesesuaiannya dengan ketentuan peraturan-perundang-undangan, baik secara legal formal maupun substansial seperti yang dicita-citakan oleh peraturan perundang-undangan. Pengumpulan data dilakukan melalui observasi, wawancara, dan dokumentasi. Aktivitas dalam analisis data terdiri dari tiga alur kegiatan yang terjadi secara bersamaan, yaitu: reduksi data, penyajian data dan penarikan kesimpulan/verifikasi. Hasil penelitian menunjukkan bahwa secara umum penyusunan RPJM Desa di desa Randuagung telah dilakukan sesuai dengan peraturan perundang-undangan, baik secara legal formal maupun secara substansial. Secara legal formal kesesuaian proses penyusunan dibuktikan dengan: 1) proses penyusunan dilakukan sesuai dengan tahap-tahap penyusunan RPJM Desa yang ditetapkan dalam peraturan perundangan, 2) kegiatan perencanaan diselenggarakan oleh pemerintah Desa; 3) kegiatan perencanaannya melibatkan Badan Permusyawaratan Desa; 4) kegiatan perencanaannya melibatkan unsur masyarakat; 5) kegiatan perencanaannya dilakukan secara partisipatif; 6) kegiatan perencanaannya dilakukan guna pemanfaatan dan pengalokasian sumber daya desa dalam rangka mencapai tujuan pembangunan desa; dan 7) menghasilkan dokumen RPJM Desa. Kesesuaian secara substansial dibuktikan dengan: 1) Isi dokumen RPJM Desa Randuagung sesuai dengan sistematika yang ditetapkan dalam pedoman; 2) visi, misi, tujuan, sasaran dan strategi dirumuskan dengan jelas; 3) mengatur rencana program indikatif dirumuskan secara terperinci dan jelas berdasarkan pengelompokan bidang pembangunan; 4) setiap rencana program kegiatan dilengkapi dengan rencana anggaran biaya yang jelas dan terukur.

ABSTRACT

Title : "Formulation of the Randuagung Village Medium Term Development Plan Towards Independent Villages"

This study aims to describe the formulation (preparation process) of the Village Medium Term Development Plan towards an Independent Village, seen from its compliance with statutory provisions, both legally and substantially as aspired by statutory regulations. Data collection was carried out through observation, interviews, and documentation. Activities in data analysis consist of three activities that occur simultaneously, namely: data reduction, data presentation and conclusion / verification. The results showed that in general the preparation of the village medium term development plan in Randuagung village was carried out in accordance with statutory regulations, both legally and substantially. Legally formally the suitability of the drafting process is evidenced by: 1) the compilation process is carried out in accordance with the stages of drafting the Village RPJM stipulated in the legislation, 2) planning activities are carried out by the Village government; 3) planning activities involve the Village Consultative Body; 4) planning activities involve elements of the community; 5) planning activities are carried out in a participatory manner; 6) planning activities are carried out for the utilization and allocation of village resources in order to achieve village development goals; and 7) produce a Village RPJM document. Substantial compliance is proven by: 1) The contents of the Randuagung Village RPJM document are in accordance with the systematics stipulated in the guidelines; 2) clearly formulated vision, mission, goals, objectives and strategies; 3) arrange indicative program plans formulated in detail and clearly based on the grouping of development sectors; 4) each activity program plan is equipped with a clear and measurable budget plan.
